Don,

I don't believe Randy's letter was sent out. Stacy and I talked about Randy's directive to include it with "statements" and have NOT added anything about this in any communication that I know of. Randy talked about the incident and has gotten everyone stirred up over the discussions. Nothing has been decided so no communication should be given to our user group.

Wendell and I talked with Phil Eberly and my understanding is there is no FAA regulations that we are violating in allowing the grass operations east of our paved runway. If we want to curtail the operations it would be due to our concerns of liability of aircraft landing on an area that is not maintained as a runway by the airport. If there should be debris or sink hole that developed in the area and an aircraft was damaged, what liability would the airport authority have?

Are we willing to accept the liability of such an event? Do we want to establish a practice of maintaining the grass area to the east of the paved runway as a sanctioned landing area?

I don't believe this is a subject that requires an immediate decision and can be covered in our next authority meeting. I do believe a conversation with the pilot of the plane that was involved with landing between the taxiway and runway is in order.

Hope this helps shed some light on the current situation. I'll be back from Germany Thursday afternoon and available for phone calls at that time.

Phil: I went on Foreflight which is an aviation database used by many pilots to see what light it might shed on flight operations at KJZP. Here is what I found:

- 1. The Touch Down Zone Elevation (TDZE) for Runway 16 is 1515 feet Mean Sea Level (MSL) while the TDZE for Runway 34 is 1535 meaning Runway 34 slopes downhill 20 feet in 5,000 feet. That is a 4% downhill gradient. If the runway is not uniformly level, neither is the grass.
- 2. There are two Instrument Approach Procedures for KJZP, the RNAV/GPS for Runway 16 and the RNAVGPS for Runway 34. Both Instrument Approach Procedures contemplate the pilot landing on a paved runway. I can find nothing in the data on this airport authorizing landing on the grass. If the paved runway as closed by a Notice to Airmen in May of 2022, when someone landed on the grass, I would ask the pilot on what authority did he land on the grass as opposed to the runway. I cannot find anything in the data on the airport that would permit such an operation.

If we are going to have a meeting on the week of July 4 or July 11, I would respectfully ask for the following in advance of any meeting:

- 1. A copy of the current Airport Layout Plan (ALP);
- 2. A copy of the Airport Rules;
- 3. A copy of any minutes of meetings where complaints of Mr. Denison's clients were raised before the Pickens County Airport Authority or Pickens County Board of Commissioners;
- 4. All correspondence between the Pickens County Airport Authority and/or Pickens County Board of Commissioners and the clients of Mr. Denison:
- 5. All Grant Assurance Agreements between Pickens County and the Department of Transportation/Federal Aviation Administration for the past 20 years;

- 6. The T-Hangar List for KJZP;
- 7. Any rules concerning parking cars on the airport ramp or common areas;
- 8. Any rules concerning access to bathrooms, especially at night and after hours;
- 9. Any other documents in your possession that you believe would be helpful in helping me understand what has taken place on the airport; and
- 10. Copies of any and all leases, contracts or other documents evidencing agreements between Mr. Denison's clients and the Pickens County Airport Authority and/or the Pickens County Board of Commissioners.

The FAA Airport Nondiscrimination Compliance Program has received a complaint related to Pickens County Airport (JZP). The complainant alleges that Pickens County Airport Authority ("the Authority"), the owner and operator of JZP, discriminated against the complainant on the basis of sex, in violation of the Airport and Airway Improvement Act of 1982. The complainant is the only female tenant business owner at JZP, with three businesses operating at JZP. The complainant alleges that the Authority treated the complainant differently than similarly situated male-owned businesses and male independent operators.

The complainant's specific allegations are as follows:

- 1. Starting on May 11, 2022, the JZP airport manager ordered pilots for one of the complainant's three businesses at JZP, Get Inspired Flight, Inc. (GIFT), to stop operating on the grass area on the east side of Runway 34 approach, that parallels the runway for approximately 4,000 feet. The complainant alleges that pilots of male-owned businesses and male independent operators at JZP were not prohibited from doing so. GIFT's inability to operate on the grass area creates financial hardship by preventing nearly half of GIFT's operations.
- 2. Additionally, the complainant alleges that the Authority gave preferential treatment to male-owned businesses and male independent operators regarding use of the parking ramp and onsite facilities as follows:
- A. Effective June 30, 2021¹ and continuing to this day, the Authority ordered that the ramp in front of complainant's second business, Light Sport Aviators (LSA), and Joe Aircraft (male-owned) must remain empty at all times, but does not enforce this requirement against Joe Aircraft, particularly for automobile parking and aircraft maintenance on the ramp. The Authority continues to allow Joe Aircraft to perform maintenance on its aircraft and to

park automobile vehicles belonging to its staff, associates,² and customers on the ramp area that is supposed to be kept clear. To comply with the Authority's order, complainant cut the tie down ropes for their aircraft, at the tie down rented by LSA, forcing LSA to hangar their aircraft after each lesson, but Joe Aircraft continues to use the ramp for its aircraft tie downs.

- B. The complainant's requests for a key to the FBO/terminal for GIFT on January 10, 2022; January 29, 2022; and March 12-13, 2022 were denied. However, the Authority provided Joe Aircraft and two independent flight instructors³ (both male), neither of whom rent a hangar or own an airplane, with keys⁴ to the FBO/terminal, allowing them to enter 24 hours a day / 7 days a week.
- C. The Authority does not provide trash services to the Complainant that are similar to what it provides to Joe Aircraft. Joe Aircraft does not pay the Authority for trash service, but the Authority routinely takes its trash to the County dump, but not GIFT's. The Authority provides a dumpster that Joe Aircraft uses; GIFT does not use it, but the airport manager has and continues to accuse GIFT of dumping garbage in it.

The FAA Airport Nondiscrimination Compliance Program, within the FAA Office of Civil Rights, is responsible for investigating complaints that allege discrimination by recipients of Federal assistance on the basis of race, color, national origin, sex, creed, or age, as well as related acts of retaliation, in violation of Federal law. Airport sponsor recipients under the FAA Airport Improvement Program (AIP) are covered by the Airport and Airway Improvement Act of 1982 (49 USC § 471, Section 47123) (hereafter, "Sec. 47123"), which prohibits discrimination on the basis of sex. AIP grant recipients commit to comply with Sec. 47123, and related authorities and to ensure against discrimination in their activities as a condition of receiving Federal financial assistance (Airport Sponsor Assurance 30). See DOT Order 1000.12C, *The Department of Transportation Title VI Program* (June 11, 2021)⁵ and AIP Grant Assurances, 87 Fed. Reg. 25691 (May 2, 2022)⁶ (Assurance 30).

Please be advised that no one may intimidate, threaten, coerce, or engage in other discriminatory conduct against anyone because he or she has either taken action or participated in an action to secure rights protected by the civil rights laws we enforce. Any individual alleging such harassment or intimidation may file a complaint with the FAA. We would investigate such a complaint if the situation warrants. Any questions or

concerns you have regarding the investigative process and your rights can be discussed with the investigator.

We would also like to inform you that under the Freedom of Information Act (5 USC § 552) and the Privacy Act (5 USC § 552a), it may be necessary to release this information, related correspondence, and records upon request. In the event that we receive such a request, we will seek to protect, to the extent provided by law, personal information, which if released, could constitute an unwarranted invasion of privacy.

To assist us in investigating and resolving the concerns mentioned in the complaint, we ask that you send us the following information no later than the close of business on September 9, 2022. Please provide brief written responses. In some cases, it may be useful to provide pictures instead of or in addition to a written response.

- 1. Airport response to the complaint.
- 2. Describe the grass area immediately adjacent to Runway 34 on the east side of the Runway 34 approach, that parallels the runway for approximately 4,000 feet, and related policies:
 - a. Provide a general description and pictures, if possible.
 - b. Clarify how the area is supposed to be used is it designated as a landing or take off area for tailwheel aircraft (sod runway)?
 - c. What are the policies restricting use of the area for aircraft operations?
 - d. How are the policies made available to tenants and aircraft operators?
 - e. Describe how the Authority enforces restrictions for use of the grass area. If any exceptions are made, who has received an exception and what are the reasons for the exceptions?
- 3. Describe the ramp area in front of LSA and Joe Aircraft:
 - a. Provide a general description and pictures, if possible.
 - b. Clarify how this ramp area is supposed to be used.
 - c. What are the policies restricting use of this ramp area, including for tenant aircraft and automobile parking?
 - d. How are the policies for use of this ramp area made available to tenants and aircraft operators?
 - e. Describe how the Authority enforces restrictions for use of this ramp area. If any exceptions are made, who has received an exception and what are the reasons for the exceptions?
- 4. What is the policy regarding which tenants are granted terminal/restroom keys? If any exceptions made, who has received an exception and what are the reasons for the exceptions?
- 5. What is the policy regarding use of the trash dumpster near Joe Aircraft, including for tenants leaving trash in the dumpster? How is the policy enforced? If any exceptions made, who has received an exception and what are the reasons for the exceptions?
- 6. Has the Authority or any of its representatives accused GIFT or its representatives of dumping their trash in Authority-controlled or other tenant-controlled dumpsters, without permission? If so, please explain the reasons.

Lastly, in accordance with DOT Order 1000.18, we invite you to meet with our staff to discuss options for informal resolution. The Order encourages early informal resolution as an alternative to formal investigations. It can be initiated at any stage of the complaint investigation process.
